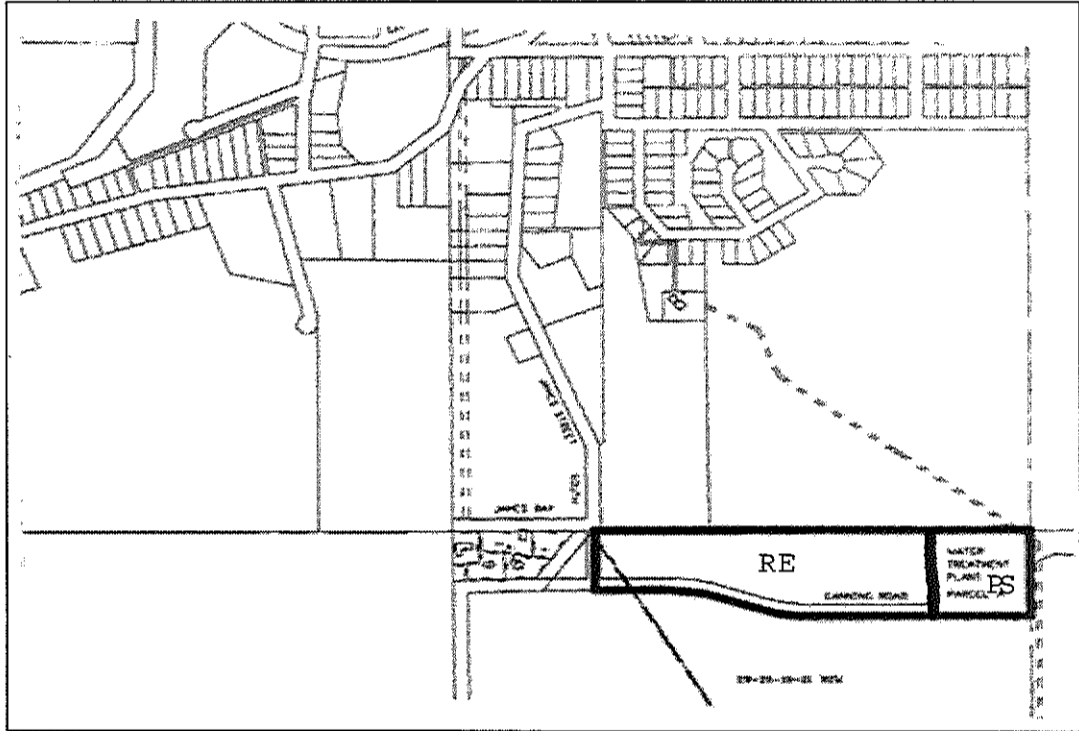
A BYLAW TO AMEND BYLAW No. 15-2002, THE ZONING BYLAW

1. Authority

Pursuant to Section 67, of The Planning and Development Act, 1983, the Council of the Town of Lumsden, in the Province of Saskatchewan, hereby amends the original Zoning Bylaw No. 15-2002 by enacting this bylaw.

2. MAP CHANGE – GUY and LORINDA JOHNS LAND

The Zoning District Map (Zoning Map 1.00 and 1.01) referred to in section 5.2 of Bylaw No. 15-2002, the Town’s Zoning Bylaw, is amended by rezoning the area shown below in the solid bold line and described as the Ptn. SW 28-19-21-W2, to the “RE” Residential Estate District and rezoning Parcel “A” to “PS” Public Service District, in the Town’s Zoning Bylaw.



3. REPEAL OF BYLAW

Bylaw 7-2004 is hereby repealed

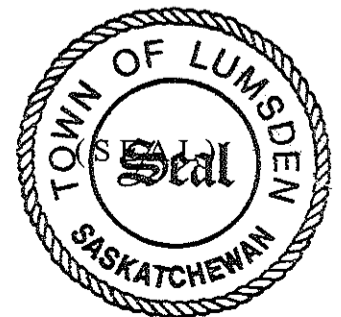

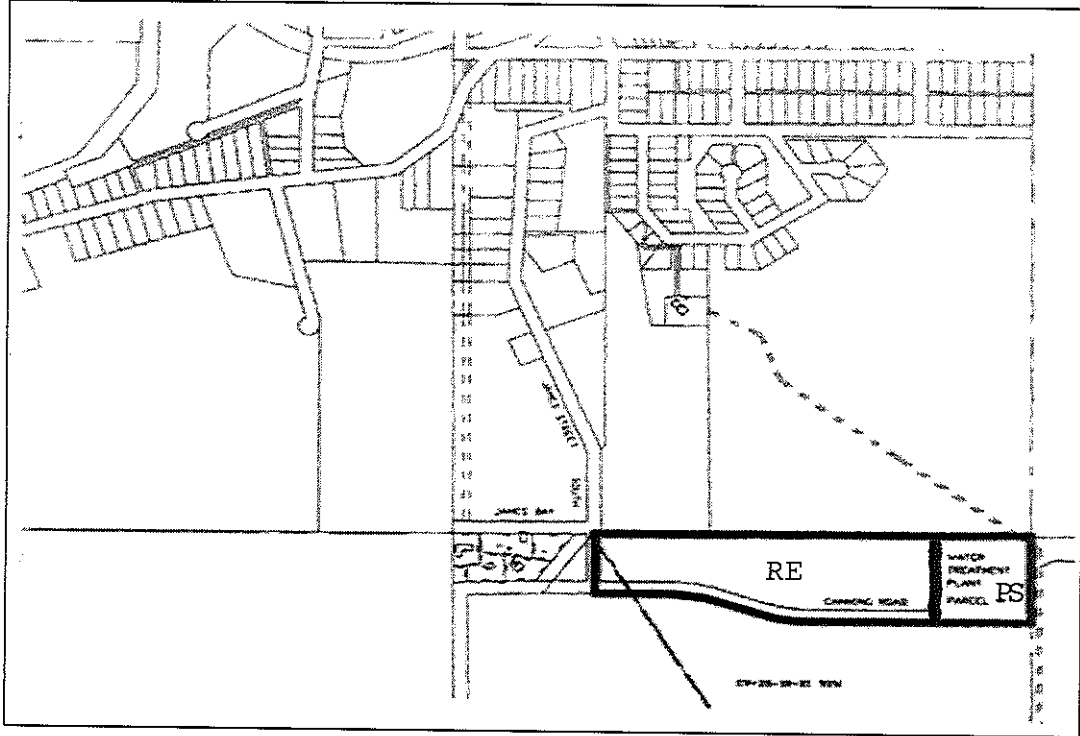
A BYLAW TO AMEND BYLAW No. 15-2002, THE ZONING BYLAW

3. REPEAL OF BYLAW

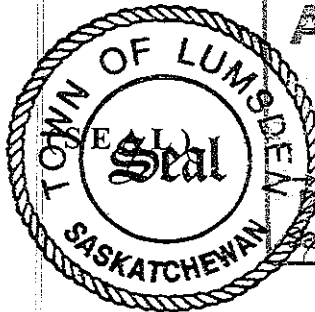
Bylaw 7-2004 is hereby repealed
