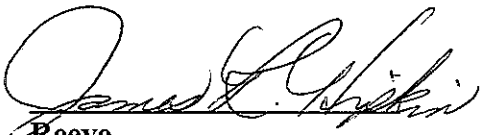
Council went into Committee of the Whole at 9:15 p.m. to discuss 2006 Public Works Salaries and Senior Staff evaluations.

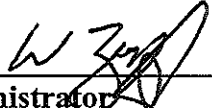
