The Lumsden Rural Municipal Finance Committee convened their budget meeting in the Council Chambers of the R.M. Office, on the afternoon of Thursday, April 7th, 2011 at 1:00 p.m. with Chairman Jim Atcheson presiding.

Public Works Manager, Don Barnett presented the following suggestions for determining the priority of public works projects:

Administrator, Wayne Zerff reviewed 2010 actuals and 2011 budgeted amounts with the Committee for both operating and the capital projects. Wayne reviewed the effects of Tangible Capital Asset PSAB Accounting principles and the impact on the budget. Wayne prepared the 2011 proposed budget with a 1.5 mill rate increase for 2011.

General Discussions:

Assistant Administrator, Darcie Cooper reviewed the project rankings completed by the Public Works Committee at their meeting on April 5th and indicated that all low ranking projects were moved to 2012. The total for the projects ranked High by the Committee are \$1,194,718, the Medium Projects totalled \$330,800 and the projects Ranked Low totalled \$607,600.

The Public Works Committee reviewed the projects ranked High and Medium and prioritized projects for the 2011 budget.

The Committee discussed financing a portion of the hot mix overlay required for the improvement and protection of existing pavement on Old Hwy No. 11 (Grid 734) by way of a loan.


