Beaver Control Program Bounty Hunter Designation

Background Information:

The R.M. of Lumsden No. 189 (RM) is participating in the Beaver Control Program (BCP) administered by the Saskatchewan Association of Rural Municipalities (SARM) and funded by the Ministry of Agriculture and the Federal Government. Bylaw No. 9/94 of the municipality, passed pursuant to Section 4 of *The Wildlife Regulations, 1981* allows beavers to be hunted in the municipality. Council must designate Bounty Hunters by resolution.

Terms:

Designated individuals must be residents of the RM of Lumsden No. 189 and provide the land location(s) where the beaver is caught within the boundaries of the RM, to be eligible for payment. The tails must be delivered to the RM where staff will verify payment eligibility. Designated individuals must obtain landowner permission to hunt or trap on private property.

All individuals designated by the RM must ensure that they abide by all legislation pertaining to the possession of firearms, if applicable, *The Wildlife Act 1998* and *The Wildlife Regulations, 1981* and any other relevant legislation.

Application Procedure:

In order for individuals to collect bounty funding provided by the BCP, they must be designated by the Council of the municipality. Please see the attached Bounty Hunter Designation Application form.

Application Approval:

If the Council of the RM of Lumsden approves the designation, it is valid for a period of time as outlined in Council's approving resolution.

Application Denial:

If an application is denied by Council, the decision is final.

Costs:

The Bounty funding received through SARM is \$15.00/tail and is matched by the RM for a total bounty of \$30.00/beaver tail.

The municipality submits a claim annually to SARM, to obtain funding at a rate of \$15.00 per tail deposited with the municipality.
