- A service agreement shall be signed with the municipality which includes a requirement to pay \$3,800.00 in off-site servicing fees to the municipality,
- Payment of the Water and Sewer Connection fees of \$1,500.00 each to connect to the water and sewer mains
- Payment of Cash in lieu of municipal reserve in the amount of \$812.50; and

That we are not aware of any land uses in the vicinity that would be incompatible with the intended use of the proposed site or any site conditions that make the land unsuitable for the intended use; and

That we do not have any facilities that could be affected by the proposed development."

2009 Council Remuneration:

Indemnity	shall include all council meetings and duly called and documented committee meetings (minutes taken by the Administrator);
Per Diem	- \$116.16 per day while attending to Town business; - \$10.96 per hour for informal meetings of a short duration where the member represents the Town or attends to Town business and a written report is provided to Council on the matters discussed or attended to.
