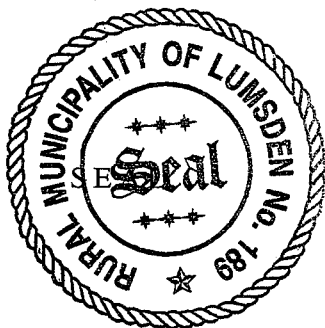
A BYLAW TO REGULATE THE SPEED OF VEHICLES ON GRID ROAD 734

The Council of the Rural Municipality of Lumsden No. 189, in the Province of Saskatchewan enacts as follows:

- 1. Definitions:
  - (a) "highway" means a road, parkway, driveway, square or place designed and intended for or used by the general public for the passage of vehicles, but does not include any area, whether privately or publicly owned, that is primarily intended to be used for the parking of vehicles and the necessary passageways on that area; as defined in the Traffic Safety Act, Chapter T-18.1 of the Statutes of Saskatchewan, 2004.
  - (b) "motor vehicle" means a vehicle propelled or driven by any means other than by muscular power; as defined in the Traffic Safety Act, Chapter T-18.1 of the Statutes of Saskatchewan, 2004.
- 2. No person shall operate a motor vehicle at a speed greater than 70 km per hour on the highway located on the southeast of section 3, township 19, range 20, west of the second meridian (SE 03-19-20-W2) along Grid 734.
- 3. Signs indicating the maximum speed allowed shall be erected at the commencement of the speed zone area and signs shall be erected showing the end of the speed zone area.
- 4. That this bylaw shall come into force and take effect once approved by the Highway Traffic Board.

Read a first time this 15<sup>th</sup> Day of August 2013.  
 Read a second time this 12<sup>th</sup> Day of September 2013.  
 Read a third time this 12<sup>th</sup> Day of September 2013.

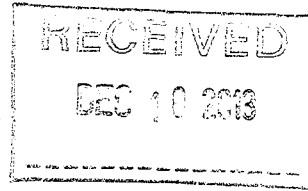
