

SNOW PLOW CLUB AGREEMENT

THIS AGREEMENT made in duplicate between:

The Rural Municipality of Lumsden No. 189
Box 160, Lumsden, Saskatchewan, S0G 3C0
(hereinafter called the "*Municipality*")

AND

(hereinafter called the "*Club*")

Made for the purpose of snow removal from roads in the municipality for the benefit of the community and members of the *Club* for the winter season of **2009/2010**.

For the purposes of this agreement one or more members shall constitute a snow plow club. In consideration of the Agreement with the *Municipality*, the *Club* covenants and agrees as follows:

1. To provide and install one yellow flasher warning light on each snow plow unit (either on the tractor or on the plow) and to locate such warning flasher light not less than eight feet above the road level.
2. To provide two warning flares for each snow plow unit for use in case of an emergency as a danger warning to approaching traffic.
3. To use such methods of snow removal as shall insure the preservation (without damage or injury) to culverts, bridges or approaches thereto, road beds or the grading thereof, and the removal of gravel or any part thereof. The *Club* and its members shall be held responsible and liable to the *Municipality* for a sum of money sufficient to cover cost required to repair any damage done or resulting from the operation of the snow plows.
4. To submit a sketch map to the *Municipality* for approval of the road mileage for which the Club accepts the responsibility of snow removal.
5. To keep a record of all work done and hours employed by members of the club while snow plowing roads.

In consideration of the above covenants by the *Club* and its members, the *Municipality* covenants and agrees as follows:

1. To accept members of the *Club* as employees of the *Municipality*.
2. To provide public liability insurance protection for members of the *Club*.
3. To provide Workers' Compensation insurance protection for members of the *Club*.
4. The *Municipality* agrees to pay to the *Club* a grant of **\$30** per mile set out by resolution **# 107-01** of the Council at a regular meeting of the said municipality held on **April 9, 2001**. Such grant to be based on the number of miles of road for which the *Club* has agreed to accept the responsibility for snow removal. Such mileage approved by the *Municipality*.

PROVIDED that this agreement may be terminated by either party hereto, by giving seven days written notice to the party hereto. Such termination notice to be delivered direct or sent by registered letter.

IN WITNESS HEREOF the parties hereto have caused this Agreement to be signed by their proper officers in that behalf.
